Addressing homelessness

In a year marked by the COVID-19 pandemic, access to safe and secure housing has never been more important. But we know eliminating homelessness is more than just about housing. The pathways both in and out of homelessness are complex and interconnected, and the solutions lie in many groups and organisations working together.

With this in mind, we work to address homelessness across three levels.

1.

acting for or advising people who are experiencing, or at risk of, homelessness through our relationships with legal clinics including Street Law (Canberra), Justice Connect Homeless Law (Melbourne), PIAC's Homeless Persons' Legal Service (Sydney), Street Law Centre (Perth) and LawRight (Brisbane);

2.

providing pro bono legal advice and/or financial support to organisations working to support those without access to safe and secure housing, including Whitelion, Brisbane Youth Service, Hutt St Centre, 3rd Space, Housing All Australians, KARI, YourTown,

WAGEC, My Foundations Youth Housing, Stepping Stone House (Sydney Stepping Stone Inc), Tenants Queensland, Wintringham and StreetSmart: and

leveraging our networks and relationships to drive systemic change by bringing together community organisations, businesses, industry, government and people with lived experience of homelessness. In the past year, we have expanded our work with The Constellation Project, Brisbane Youth Service and Housing All Australians. We have assisted the Property Industry Foundation on the development of purposebuilt housing for young people at risk of homelessness. And we were proud to support our long-term partner Whitelion's inaugural 'No Home Address' campaign, which raised more than \$250,000 for youth at-risk of homelessness





The Constellation Project: we believe that homelessness is solvable

The Constellation Project's (TCP) vision is to end homelessness in a generation. The cross-sector collaboration was founded by Australian Red Cross, the Centre for Social Impact, Mission Australia and PwC Australia, who joined forces in the belief that together we stand a better chance of driving action on homelessness. It brings together corporates, governments, people with lived experience, academia, philanthropists and not-for-profits.

We have been working with TCP for three years, and were pleased to join as an Alliance Member this year. Led by Keith Rovers, our Pro Bono team advised TCP on its incorporation as a Not-For-Profit entity under the name 'Constellation Project', involving a merger with the Business Alliance to End Homelessness initiative. Along with Keith Rovers' role as a director of Constellation Project, MinterEllison continues to provide advice and support on governance, charity registration and operations, as well as technical expertise in areas of law relevant to solutions to increase the supply of social and affordable housing.


As part of The Constellation Project, our people work across a range of social labs engaging with Aboriginal and Torres Strait Islander individuals and voice, people with lived experience of homelessness and domestic and family violence, along with some of our key clients - financial institutions, developers CHIA, NHFIC, CEFC, Social Ventures Australia, NSW Government and other like-minded organisations. Together we are developing policy and integrated solutions across inclusionary zoning, accessing and unlocking private capital, domestic and family violence and other programs to address the underlying causes of homelessness.

We believe investment in social infrastructure is a critical aspect of the social capital that binds us together and provides the basis for our success as a community. Homelessness is a multi-faceted issue with no single solution, but with long term commitment, together we can hope to create lasting impact.

Challenge DV

Workplace Domestic and Family Violence Training

We've always been proud to bring the best of our firm to our longstanding partnership with Challenge DV (formerly Australia's CEO Challenge), whose vision is to create a world without violence.

This past year, however, our work with Challenge DV has looked a little different. In particular, we were pleased to provide both legal and operations assistance to Challenge DV to support their successful rebrand – a significant transformation given their 20+ year history as Australia's CEO Challenge.

Competition Risk and Regulatory
Partner Vanessa Mellis advised on the
legal aspects of the rebrand. From an
operations perspective, Mathilda Spence
in our Change and Transformation
team provided change management
guidance, drawing in additional support
from our IT and Talent teams.

Led by Brisbane Partner Jonathon Williams, MinterEllison's 2021 Darkness to Daylight team achieved record participation and fundraising levels. More than 250 people from across MinterEllison signed up to walk or run up to 110,000km over the month of May, raising more than \$30,000 for domestic and family violence prevention.

Despite the interruptions of COVID-19, we were also pleased to have been able to lock in the ongoing provision of physical space for Challenge DV in our Brisbane office. A true example of bringing our whole firm to our community partners.


Access to justice for all in our community

We approach our ongoing commitment to improving access to justice with a spirit of purpose and partnership. Our people are passionate about using their legal skills to assist individuals who might otherwise lack access to legal information, advice or representation. As a firm, we work collaboratively with community legal centres, advocacy groups, specialist legal clinics and referral services to understand where our skills and resources best match unmet community need. Our casework also informs the strategic policy work and advocacy of our community partners which supports ongoing law reform and improves outcomes across our communities.

In addition to our lawyers working in legal clinics across Australia, we were also proud to use our collective skills and resources to support the community legal sector in a number of other ways. Some of these included hosting Train the Trainer events for Marrickville Legal Centre's Migrant Employment Legal Services, sponsoring regional and remote transport for Community Legal Centres Queensland State Conference 2021 and our Corporate Services team providing printing support to the 2021 Community Legal Centres NSW State Conference.

In FY21, our people also walked the talk. 40 people from our Brisbane office took part in the 2021 Queensland Legal Walk, which raised over \$100,000 for LawRight. And a team of 10 from our Perth office joined the 2021 Law Access Walk for Justice, which raised a total of \$117.015.

Justice Connect

The crisis of homelessness in Australia sees some 116,000 people without access to a home on any given night. Social justice organisation, Justice Connect, knows that homelessness is a complex issue that requires systems-level change, and, through its Homeless Law service in Victoria, challenges and changes laws that unfairly affect people facing homelessness. Homeless Law provides outreach-based, client-centred and holistic legal help to people experiencing or at risk of homelessness, primarily in the areas of tenancy and housing, and fines and infringements.

MinterEllison was one of the founding law firm partners of this service, then known as the Homeless Persons' Legal Clinic. Our lawyers have attended a weekly outreach clinic for close to 20 years. The relationship has become embedded in our Pro Bono and Community Investment Program to such an extent that every graduate lawyer who joins in our Melbourne office becomes a member of the Firm's Homeless Law team.

Our commitment to working alongside Homeless Law underpins our vision to achieve the best possible result for the clients we work with. Our work also supports Homeless Law's evidence-based systemic advocacy for positive change, which is focussed on stopping homelessness before it starts, and preventing the criminalisation of homelessness. Last year, we worked some 5300 hours, on more than 100 matters, that, in many cases, assisted clients to avoid eviction into homelessness or to deal with their fines, which are barriers to safe and secure housing.

For our graduates and lawyers, their work in the Homeless Law service is often one of their first experiences working directly with a client, managing a file, appearing in court or a tribunal, and negotiating on behalf of a client. Many of our people find it to be a career and life defining experience, where they have an opportunity to view the law through the lens of people facing challenging circumstances. It is a privilege for our people to learn from the strength and resilience of our clients.

Justice Connect increases access to legal support and progresses social justice in our community. We are honoured to assist them.

Empowering youth through education, mentoring and access to secure housing

This past year has been one in which young Australians have shown extraordinary resilience. But it was also one in which students and vulnerable young people have needed more support than ever to combat the social isolation, mental health challenges and shift to virtual learning brought about by COVID-19.

In FY21, we provided pro bono and community investment support to organisations supporting young people with their education, providing safe spaces for those experiencing (or at-risk of) domestic and family violence, and those without secure housing.

One of the core ambitions in this space is to support tertiary education pathways for young people who might otherwise not have been able to get to university. Over the past year we expanded our national student mentoring partnership with ABCN, and financially supported First Nations scholarships at Bond University and the University of South Australia, The Anton Hermann Memorial Scholarship at Monash University, 8 Glenala State High School scholarships and ABCN's Accelerate program.

The Firm and our Brisbane Vacation Clerks contributed to the Furnishing Young Futures initiative, an innovative collaboration between Brisbane Youth Service and Brisbane Housing Company, designed to support young residents' transition from crisis accommodation to safe and stable housing.

Our PRIME Network continued to raise funds and awareness for the Pinnacle Foundation, which provides mentoring and opportunities for young LGBTQ+ Australians.

And, in what has been a devastating period for the arts industry, we endeavoured to create lasting impacts by sponsoring and providing pro bono legal and consulting support to organisations empowering young people pursuing creative careers. From WAYJO (West Australian Youth Jazz Orchestra) in Perth, to Australian Theatre for Young People in Sydney.

This is just a snapshot of MinterEllison's work to create lasting impacts for young people in Australia.

Australian Business and Community Network (ABCN) Bridging the digital divide

Over the past year technology has played a more important role in education than ever before.

Accessing virtual classrooms, necessitated by lengthy COVID-19 lockdowns, required students to have access to a home computer and internet connection - which not everyone has available to them. Particularly not one for every sibling to use simultaneously.

Schools had to quickly pivot to online education and school programs.

And ABCN, a MinterEllison community partner of over 15 years, had to quickly adapt its mentoring programs to focus on a digital approach in order to continue and build those vital mentoring relationships between mentors and students.

As a firm, we were keen to help however we could.

We worked flexibly with ABCN to ensure our mentors were still able to connect with students, including through new digital programs, and were proud to have more than 100 mentors across MinterEllison participate in more than 16 ABCN programs in FY21.

We also provided pro bono legal advice to ABCN on privacy and other considerations relating to the use of digital platforms.

Vitally, our Digital team have delivered more than 100 decommissioned MinterEllison laptops, supporting technology and iPhones to students and schools across Australia, in an initiative led by Dolly Sequiera, IT Procurement Manager, Sydney. Ensuring students like Arezo, a refugee and Accelerate scholar at Lynwood High School, have equitable access to learning, setting them up for a bright future.

Our Digital team were also pleased to be able to provide ABCN with IT training on the digital platforms now needed to power their programs.

We were also proud to reintroduce our financial sponsorship of ABCN's Accelerate program, a three-year scholarship program targeting exceptional students whose economic, family or social challenges are impacting on their study or capacity to pursue their desired tertiary pathways. MinterEllison's Talent team were able to further support by volunteering their time and expertise reviewing sponsorship applications.

Reconciliation: respect, relationships, opportunities

We partner with organisations that empower First Nations communities across Australia and provide access to justice. We are committed to improving employment outcomes, using our purchasing power and networks to support Aboriginal and Torres Strait Islander businesses, and building economic opportunities through our supply chain.


Over the past year we established a new Victims of Crime Assistance Tribunal referral service with Victorian Aboriginal Legal Service (VALS). We continued our strong partnership with KARI, including providing foundational advice on their newest social enterprise, KARI Aboriginal Procurement. Our Perth Dispute Resolution team's work with Tidal Moon has secured the businesses operations, which in turn made a real difference to employees and their families. And our COVID-19 vaccination drive across the firm raised funds for the Moriarty Foundation's IndiKindi health and education program. Despite COVID-19 impacts we continued to work with key

Indigenous business suppliers including Kulbardi, Nallawilli Water, Orana Commercial, Murawin, Integrity Health and Corporate Culcha to procure a diverse range of goods and services.

We are committed to establishing new scholarships in the NT and WA, and continuing to build our relationship with Bond University. And in 2022, we look forward to launching an innovative law reform workshop with the University of NSW to progress issues of importance to First Nations people.

Recognising the importance of employment pathways, we have assisted several Indigenous Businesses providing upskilling and job opportunities to First Nations Australians, including Muru Mittigar, Feraliser, APY Art Centre Collective, Diilpin Arts Centre, SevGen Indigenous Corporation, Indigenous Employment Partners and Currency Print and Corporate Communications.





Victorian Aboriginal Legal Service (VALS)

In April 2020 MinterEllison formalised an arrangement with Victorian Aboriginal Legal Service (VALS) to run a referral service for clients requiring assistance with Victims of Crime Assistance Tribunal applications in Victoria. VALS was established to address the overrepresentation of Aboriginal and Torres Strait Islander peoples in the criminal justice system and provides referrals, advice, information, duty work or case work assistance to Aboriginal and Torres Strait Islander peoples in the State of Victoria.

In addition, we seconded lawyer Maddison Smith to VALS' Civil and Human Rights team to work alongside the VALS team.

Supporting an award-winning partnership protecting the world's oldest rainforest

Rainforest 4 Foundation exists to help communities protect and restore the Earth's rainforests. They do this by purchasing land, creating new protected areas, stopping and reversing the impacts of development, and restoring rainforest ecosystems damaged in the past.

Rainforest 4 Foundation is purchasing land in Far North Queensland to ensure it is protected from development and managed for conservation. The Foundation works in partnership with Jabalbina Yalanji Aboriginal Corporation to acquire properties in the Daintree Lowland Rainforest and transfer ownership of those properties to the Traditional Owners, the Eastern Kuku Yalanji people.

This unique partnership was recognised in the 2021 Queensland Reconciliation Awards winning the Premier's Reconciliation Award and the Partnership Award.

Moving Feast

The impact of COVID-19 on vulnerable people continues to be profound. And while government assistance has provided relief to some, social enterprises have worked to fill the need created by the pandemic and ensuing lockdowns.

One of the social impact initiatives we have been proud to assist is Moving Feast – a collaboration of social enterprises that responded quickly to COVID-19 in the first half of 2020 by looking in a systemic way at how food is created, distributed and consumed. Their goal is creating a pandemic food response imbued with justice, sustainability and resilience. Moving Feast started with a few corporate cafes collaborating on pandemic

food relief with a 'gate to plate' mindset and has grown to work in all areas of the food system from growing, storage, cooking, distribution, and education. We assisted Moving Feast by working on a corporate governance architecture suitable for bringing together the participating social enterprises.

Moving Feast continues to grow, cook, and deliver meals to help the most vulnerable Victorians while keeping hundreds of staff employed. By collaborating with other social enterprises to provide, for example, transport logistics they are also creating wrap around services to people who are usually excluded from the open labour market.
