### Last Clear Chance (Last-Clear-Chance Doctrine)

A defense to negligence that the plaintiff was the last person who could have avoided an injury. The last clear chance is a rebuttal to a defense of contributory negligence (or hybrid comparative negligence) raised if the defendant had the last clear chance to act so as to avoid the accident or other cause of the plaintiff's own harm, regardless of any contribution of responsibility for that harm may be attributed to the plaintiff. If the defendant could have reasonably acted to avoid injury, then even if the injury was otherwise caused in part by the plaintiff, the defendant may not assert contributory negligence or a similar defense to bar all liability. Last clear chance has sometimes been asserted as a technique of assessing plaintiff's conduct under theories of contributory or comparative negligence.

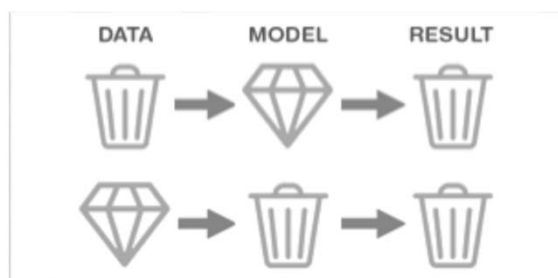
